Your subordinate is a bully, and your letter confers she is your pit-bull too.

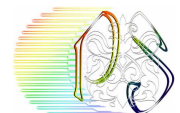
You disgrace yourself and your position with such a response, and as I have had to before, I am dismissing you too.

We shall see, dear man, we shall see.


Lead in order to serve, not in order to rule.

You owe me an apology, but please feel safe that no matter what I will not make a legal issue of my claim unless my condition is breached.

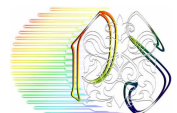

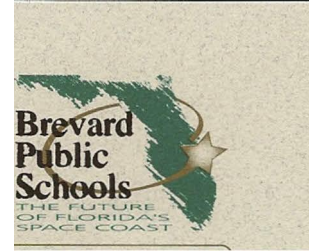


